FORMAT & SCORING

- **EACH MATCH IN DIVISION AND BRACKET PLAY ARE BEST 2 OUT OF 3 GAMES.**
ALL DIVISION AND BRACKET GAMES (EXCEPT TROPHY MATCHES AS NOTED BELOW) WILL BE PLAYED TO 25 POINTS WITH A 30 POINT CAP.
TROPHY MATCHES WILL BE PLAYED TO 25 WITHOUT A CAP.
- **DIVISION PLAY IS FOLLOWED BY BRACKET PLAY**
- **DIVISION PLAY MATCHES WILL START ON TIME. ONCE 2 MATCHES HAVE BEEN COMPLETED, THE NEXT MATCH STARTS IMMEDIATELY FOLLOWING THE CONCLUSION OF THE PREVIOUS MATCH**
- **DIVISION PLAY DETERMINES PLACEMENT IN THE CHAMPIONSHIP BRACKET**
ALL TEAMS ADVANCE TO THE FIRST ROUND OF THE CHAMPIONSHIP BRACKET
1ST PLACE DIVISION FINISHERS WILL PLAY 4TH PLACE DIVISION FINISHERS
2ND PLACE DIVISION FINISHERS WILL PLAY 3RD PLACE DIVISION FINISHERS
